Pursuant to the National Institute of Justice (NIJ) 2005 Interim Requirements for Bullet-Resistant Body Armor, I, on behalf of the above-named manufacturer, hereby acknowledge the following to the National Institute of Justice, Office of Justice Programs, U.S. Department of Justice:

1. Recent NIJ research findings indicate that certain body armor models that were found by NIJ to be compliant with earlier NIJ requirements for ballistic resistance of new body armor (including NIJ Standard 0101.04) may not adequately maintain ballistic performance during their service life;
2. NIJ recommends that those who purchase new bullet-resistant body armor on or after September 26, 2005 (the effective date of the NIJ 2005 Interim Requirements) select body armor models that comply with the NIJ 2005 Interim Requirements;
3. Effective September 26, 2005, NIJ will no longer publish lists of models found by NIJ to be compliant with earlier NIJ requirements for ballistic resistance of new body armor (including NIJ Standard 0101.04); and
4. Any list or database of compliant body armor models published or sponsored by NIJ on or after September 26, 2005, will include only models that are found by NIJ to comply with the NIJ 2005 Interim Requirements.
